Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER) which provides key information on the 2021-2022 educational progress for the Colfax County Township School District #1F – Big Burning School. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. For the 2021-2022 school year, schools were identified using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that has a student subgroup performing at the same level as the lowest 5% of all schools in the state. A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state or has a graduation rate at or below 67%. Some schools are not identified with any of these labels. In these cases, no label is given.

Our school was not identified.

A key challenge for our school is the small school size. In any given year, one student may make up 50% or even 100% of the scores for a particular grade level. Another challenge for our school is Science and Social Studies scores. According to MI School Data from M-STEP – the lowest area of performance on the 2021-2022 M-STEP was in Science and Social Studies.

State law requires that we also report additional information.

1. PROCESS FOR ASSIGNING PUPILS TO THE SCHOOL

In district pupils are enrolled automatically. School-of-choice openings, if any, are posted each year in July and January. Students are taken through

the school-of-choice program until positions are filled or the deadlines have passed.

We are in the fifth year of our 3-5 year plan.
This is the first year of our MICIP plan.

There are no specialized schools in the district.

Due to confidentiality concerns, this information cannot be reported in this format because of the limited number of available scores. Individual student scores are available to parents upon request and are sent home once tests are administered and scores are provided by the state.

6. IDENTIFY THE NUMBER AND PERCENT OF STUDENTS REPRESENTED BY PARENTS AT PARENT-TEACHER CONFERENCES

25 out of 25 students, representing 100%, were represented by parents at parent-teacher conferences in 2021/2022 as well as 2020/2021.

The faculty and school board are proud of the effort the children have shown when taking the state mandated tests. We continue to offer support for all of our students throughout the school year.
